The committee has decided to forward the issue to local police station . However as Mr.Paldendoesn't want proceed the incident as per anti-ragging law, it was decided to call all the students involved in the incident to college on 14/05/2018 for discussion.

On 14/05/2018 the committee has gathered together to discuss the further procedures. Mr Sourabh ,Mr.Tajasvi&Mr . Chandan MR expressed their guilt in occurrence of the incidence.

Mr.TseringTenzin(Mysore Tibetian Student Association President) was also present during the discussion. He requested the college authority to not to proceed the incident legally and to solve the issue with in the college.

On Mr.Tsering Tenzin request it was decided by the committee that the incident will be resolved within the college. Mr Sourabh, Mr. Tajasvi&Mr . Chandan MR were asked tom write apology letter and submit to college. It was also informed to them that any such incidents in future will not be tolerated and serious actions will be taken. Moreover the parents of the students were also informed about the incident and action taken .

All of sudden, Sourabh and his friends followed me and then suddenly they someone punched so hard on my face and i was realised it was Saurab and his gang who had planned to do so. I stopped my bike and defended myself and My friend who got injured too tried to stop the fight. They called two of their friends again and four of them had already plotted to beat me alone as they planned. They attacked me and I did my best to defence myself.

I called up one of my tibetan senior and told him everything. But he advised me to apologise those guys despite the fact that they attempted to Gang beating me. so we went to them and I beg them and I apologize to them but they were asking a sum of rupees 10000 and they even threaten me saying they will take me to court and will give complain to police. They continuously asking for money as blackmail. when I said I don't have money they even threatened me to sell my bike. I was too disturbed and felt very unsafe in Mysore. But still, I was trying to solve this problems by negotiate them of giving Rs 3000 or 8000 but they refused.
